RULES FOR USE OF THE CSPOA SWIMMING POOL

The CSPOA swimming pool is one of the amenities provided for the enjoyment of all property owners in good standing, along with their immediate families and guests as defined below.

1. **Pool Hours:** The CSPOA pool is open daily for general use between 10:00 a.m. and 8:00 p.m.
2. **Special Use of the Pool:** Everyday members may use the pool for lap swimming from 7:00 a.m. to 9:00 a.m. and the two (2) community water aerobics groups have exclusive use of the pool from 9:00 a.m. to 10:00 a.m. (Monday, Wednesday and Friday) and (Tuesday, Thursday and Saturday). General swim is from 10:00 a.m. to 8:00 p.m. everyday.
3. **Admission to the Pool:** To enter the pool a CSPOA member must use a card/fob obtained from the CSPOA office. The cards/fobs are part of an automated admission system that records every entry to the pool. Everyone entering the pool area must sign the register kept by the pool attendant.
4. **Guest Policy:** The pool may only be used by property owners in good standing and their houseguests.
5. **Food Policy:** Food is permitted within the pool area. Picnic benches are available in the adjacent picnic area for people wishing to eat outside of the pool area. Each person who brings food and beverages into the pool area is responsible for cleaning up any spills, crumbs, etc. and disposing of trash appropriately.
6. **No Smoking:** Smoking is not allowed in the pool area.
7. **Beverage Policy:** No alcoholic beverages or glass containers are permitted in the pool area.
8. **Cleanup:** Members and their guests are responsible for keeping the pool area clean and orderly. Please put umbrellas down and return chairs to the proper position when leaving.
9. **Dress:** Pool users must wear appropriate swimming attire. Children who are not toilet trained are allowed in the pool only if wearing approved swimming diapers. Regular diapers or training pants under bathing suits are not permitted in the adult pool or the children's pool.
10. **Behavior:** There is never a lifeguard on duty at the CSPOA pool; members and guests swim at their own risk. The following behavior restrictions are always in force:
 - **All children under age 14 must be accompanied by an adult at all times.**
 - **No diving from the side of the pool.**
 - **No running on the pool deck.**
 - **No pushing or horseplay on the deck or in the pool.**
 - **No squirt guns or water guns of any kind.**
 - **Non-swimmers of any age are not permitted in the deep end of the pool even if accompanied by a swimmer.**
11. **Flotation Devices:** The only flotation devices allowed in the adult pool are water wings and sea noodles.
12. **Buddy System:** Pool users must adhere to the buddy system; no individual should ever be in the pool unless other people are present.

Violation of any of these policies by a member or his/her guest may result in immediate suspension of the member's pool use privileges. Members are responsible for informing their guests about these policies.
